Trident Three: "Guilty"

On April 12th, The Trident Three were found guilty of trespassing in Federal Court. Larry Kerschner, Gilberto Perez, and Bernie Meyer appeared in United States District Court, Western District of Washington at Tacoma. Magistrate Judge David C. Christel presided over the proceedings. A large number of supporters witnessed the trial.

The defendants had their cases consolidated; their cases were all tried at the same time. Attorney Blake Kremer, who has supported and represented many nuclear resisters, represented Larry Kerschner and acted as standby counsel for Meyer and Perez. All parties had already agreed to and signed the "statement of facts" that defined the events that occurred.

On May 7, 2016, during a vigil held by the Ground Zero Center for Nonviolent Action, the three demonstrators engaged in a peaceful protest. They entered the main highway and briefly blocked traffic on the federal side of

the main gate at Naval Base Kitsap-Bangor in Silverdale, Washington. The three demonstrators carried an illustration of Fr. Daniel Berrigan, revered anti-war and anti-nuclear weapons priest, with a statement by him which read, "Know where you stand and stand there." They also carried a colorful banner with symbols linking nuclear weapons and climate change.

The nonviolent direct action was held in honor of Mother's Day. In 1872, Julia Ward Howe suggested that Mother's Day should be dedicated to peace. Howe saw the effects on both sides of the Civil War and realized that destruction from warfare goes beyond the killing of soldiers in battle.

The three resisters were arrested by base security, booked, and released. They received citations pursuant to Title 18 USC Section 1382 for trespass on a military installation.

The court, as it has done in every case involving nuclear resisters at the Bangor base, granted the government's motion in limine, which disallowed presenting any defense involving the necessity defense, international law regarding the use of nuclear weapons, to humanity and that they are united

Open letter to Gen. H.R. McMaster

General H.R. McMaster National Security Adviser Executive Office of the President 1600 Pennsylvania Avenue NW Washington, D.C. 2006

Dear General McMaster:

I just finished your book, Dereliction of Duty. Your book was a courageous indictment of the Joint Chiefs of Staff (JCS) for their refusal to give President Johnson the benefit of their military advice in 1964 and 1965 as civilian policy makers Americanized the Vietnam war.

You state their refusal to advise silently endorsed a flawed policy leading to the Americanization of the war and the deaths of over 50,000 US soldiers and over one million Vietnamese.

You state the Vietnam war was lost in Washington, D.C. Now you are in Washington, DC, our National Security Adviser. Dereliction of Duty must be on your mind as you watch civilian policy makers Americanizing war in Iraq, Syria and probably Iran that could lead to another massive misuse of those brave soldiers you have commanded in the field.

The analogies between what you recorded in your Vietnam history and today are many and alarming, are they not?

You know the Iraq war of 2003 was based on a lie, just like the Gulf of Tonkin incident.

The US installed the Catholic Diem as South Vietnam's Prime Minister. He started killing Buddhists. The US installed the Shi'a al-Maliki as Iraq's Prime Minister. He started killing Sun-

When the US civilian policy-makers overthrew Diem, the replacement Prime Minister dismantled the governing institutions, just as US Proconsul Bremer did in 2004, making Iraq ungovernable.

US military advisers were sent to "train" the army of an illegitimate South Vietnamese government, just as US advisers were sent to train the army of an illegitimate government headed by Iraq's al-Maliki. US advisers couldn't counter the governmental corruption that led to the Viet Cong gaining support in the countryside, anymore than US training prevented a Sunni insurgency in Iraq, or kept al-Maliki from abandoning Mosul in June 2014 without firing a shot.

The current President fits your description of LBJ, "a profoundly insecure man who craved and demanded affirmation." President Trump's civilian advisers have a messianic purpose to defeat Islam, just like LBJ needed to defeat "communism." LBJ's ideology blinded him to the reality of the Vietnamese resistance, just as Trump's will blinds his.

You criticized LBJ for hiding what was going on in Vietnam in order to save his Great Society. Now President Trump proposes a \$54 billion budget increase, not to strengthen the military but to hide a domestic assault on all the governmental constraints to corporate profits.

You have a President who says kill "radical Islamic terrorists," just as LBJ said "kill more Viet Cong." You said in your book that such a demand was simply "a tactical mission" and, without a clear political purpose, a waste of military equipment and soldiers' blood. In your book you denounced the very things happening today... "graduated pressure," "hit and run," "pinprick" "limited war," advisers in combat situations, and combat troops being introduced "without consideration of its long-term costs and consequences."

I know you are in a difficult spot. There is no one equivalent to a Mike Mansfield pushing President Trump to clarify his war policy, no anti-war movement teach ins, no frightened white kids facing the draft or Black conscripts dying for a country that killed Malcolm, Medgar and Martin and no equivalent to the Vietnamese boat people. Turkey, Lebanon and Jordan are warehousing refugees from our wars. If Americans saw them, as I have seen them in refugee camps, they might rethink our bombing campaigns.

Still, there are soldiers and families of soldiers who are being placed in harm's way by a destructive Chief Strategist. I hope you can call for a halt to this build-up until the military objective is clarified for the American people and explicitly sanctioned by Congress.

You quoted a passage written for LBJ by his civilian adviser, McGeorge Bundy, in 1965. It is eerie how closely it mirrors the US experience since we invaded Iraq in 2003.

"For 10 years every step we have taken has been based on a previous failure. All we have done has failed and caused us to take another step which failed. As we get further into the bag, we get deeply bruised. Also we have made excessive claims we haven't been able to realize."

Bundy continued: "We are about to fight a war we can't fight and win, the country we are trying to help is quitting. The failure on our own to fully realize what guerrilla war is like. We are sending conventional troops to do an unconventional job.... aren't we talking about a military solution when the solution is political."

If there's a mini van parked next to the driver's side of your car, crawl in through the passenger seat. There might be someone behind the dark glass waiting to open the door and snatch you.

When you're walking through an unknown place, hold your keys in your fist with the point sticking out between your fingers. Unlike a knife or gun, your keys are less likely to be turned against you.

Always be aware of your surroundings. You never know who might be hiding in the forgotten alley. Be alert when you walk alone, make sure you pay attention.

My mom teaches me what all mothers must teach their daughters in this ongoing assault on our bodies.

When it happened to me, I checked a box in the list of experiences that make woman. It was just enough of a salty, noxious taste to let me relate to all those rape poems.

When it happened to me, it didn't run at me from out of the dark, all muscle and grab. It came from the familiar. It came with an ask, but not the right ask. It came with other people in the room. After being trained to act like prey for wolves, I wasn't ready for boa constrictor.

Sexual assault is four times more likely to give you a birthday present, discuss social justice, be invited into your home or even your bed, than it is to run at you from out of the dark. It's easier to fear the monster under

your bed than the one sitting on your living room couch.

We teach our children not to take candy from strangers, but at the same time teach them to ignore their own boundaries. "Don't be shy sweetie, give Auntie a kiss. Give Daddy a smile. Say please, say please, please, please, thank you." He gave me a ride home afterward.

If I have a daughter, I will teach her everything she needs to know in this ongoing assault on our freedom. Sweetheart, know that you are so much more than someone else's prey. It's not our job to be prepared, but I'm sorry I have to tell you that it is our necessity.

Make sure you carry your keys when you walk through unknown places. You will discover doors to new opportunities you will need to unlock.

Always be aware of your surroundings. You never know what sweet, ripe mysteries might be hiding in the forgotten spaces all around you.

When you climb into your car, remember you are the driver. You've got to know who you are and where you're going.

Most importantly, know that there is nothing more sacred than your own blissful aspiration, so when someone else's desire tries to consume you in unholy ways, let your own self love burn through

Hunger strike at the NW Detention Center in Tacoma

Tacoma, WA-At noon on April 10, over 100 immigrants incarcerated at the Northwest Detention Center (NWDC) refused their lunch, launching a hunger strike to protest their treatment inside the immigration prison. The Tacoma, Washington facility, located on a superfund site, is the largest immigrant detention center on the West Coast, caging over 1500 immigrants who are facing civil deportation proceedings. Immigration and Customs Enforcement (ICE) contracts with the GEO Group, a multinational private prison corporations, to run the facility, and hunger strikers aimed their demands at both the federal government and the private contractor. The NWDC has been a frequent target of immigrant activists since a March 2014 hunger strike involving 1200 detainees first brought international notoriety to the immigration prison. A demand letter that circulated around the facility prior to the launch of the strike echoed many of the concerns raised in the 2014 strike, and includes demands for more expedited hearings, improved quality of food, improved access to medical care, and lowering of exorbitant commissary prices (strikers note that already over-inflated prices on commissary items have recently doubled). Additionally, hunger strikers are asking for an increase in the \$1 a day they currently receive for running all of the prison's basic services. Some have even been denied the \$1/day payment, and have been given a bag of chips in exchange for several nights of waxing the prison's floors.

People's Tribunal against the immigration system and the NW Detention Center

On February 26, 2017, a tribunal, sitting in the Northwest Detention Center in Tacoma, Washington, heard testimony pertaining to the detention and deportation process, conditions of the detention center, and treatment of the detainees.

People's Tribunals have a long history of being used anytime legal or political systems do not provide adequate remedy for harm in cases of abuse or injustice. The testimony [in February] demonstrated the importance of using the People's Tribunal, because our systems are clearly failing.

Based upon the testimony of the detainees, the Tribunal submits these written Findings of fact:

II. General Findings:

- A. The immigration and detention system is a part of a broader dehumanization of migrants.
- B. There is no distinction between good and bad immigrant: we are all human and deserve to be treated with respect and dignity.
- C. All migrants are economic, political, and/or social refugees of some kind.
- D. Trade agreements allow for the free flow of capital and products, but not human beings.

- E. The tribunal finds on all evidence presented before it that the United States Government, including DHS ICE/CBP, Trump Administration, State of Washington, City of Tacoma and all counties and cities and GEO Group and all contracted agencies are responsible for gross, widespread, and systematic violations of human dignity and human rights.
- F. The immigration and criminal system are one in the same and directly target people of color, immigrant communities and indigenous communities of this land whose bodies are used for labor and profit.

As it concerns to the United States Immigration and Customs Service (hereinafter "ICE") and GEO Group, City of Tacoma and the State of Washington:

- A. The two organizations (ICE and The GEO Group) passing the responsibility for inmate safety makes accountability more difficult to achieve;
- B. There are currently inadequate food/calories provided during meals;
- C. There is no access to soap and clothing
- D. Medical care is atrocious and people have died in detention and after they are released or deported because of it.
- E. The use of retaliatory solitary confinement is a common practice;
- F. The subcontracting of phone and commissary services is at exorbitant rates for a captive population.
- G. There is no adequate complaint system

As it Concerns only ICE:

- A. Wages of \$1 a day for "voluntary work" is an ongoing practice.
- B. Toxic Environmental Impacts: the Tacoma Northwest Detention Center is located on a superfund site (abandoned drums) in an industrially polluted zone, where the administrative detainees are drinking the tap water without the knowledge of the long term effects of this exposure. They are also breathing in the toxic fumes of wet paint

and floor wax because they cannot move to a different location when those tasks are completed.

Statement of demands by hunger strikers

The motive that we write this is to ask you by favor that we all participate united, and on Monday April 10, 2017, from noon and on we will not eat, or use the phones, neither will we bunk up on the late night count or lights out. The objective is to reach some changes in the institution which are the following:

- 1) Change the food (menu)
- 2) Lower the commissary (reasonable pries)
- 3) Better hygiene (with the clothes)
- 4) Increase rec-time
- Bring programs such as: school and program to keep our heads occupied and avoid depression mentally
- 6) Better medical attention
- 7) Increase wages for working detainees (waxing floors, painting, cleaning, cooking, laundry)
- B) Facilitate court proceedings (speed up the process).

Please we ask for our help and participation. Because it is not just for them to treat out the way they want without them respecting our rights! And if we speak up we don't speak up we'll always be the same.

NWDC Resistance is a volunteer community group that emerged to fight deportations in 2014 at the now-infamous Northwest Detention Center in Tacoma, WA as part of the #Not1more campaign, and supported people detained who organized hunger strikes asking for a halt to all deportations and better treatment and conditions. If we are ever going to get the kind of progressive change our society so desperately needs, we are going to have to elect representatives who will stand up to corporate power and fight for the progressive agenda that the majority of Americans want. We want things like a living wage for all, universal single-payer health care, serious criminal justice reform, transition to a clean energy economy, and no more endless wars and regime changes. Unfortunately, our congressman in Washington's 10th District, Denny Heck, is far from progressive. He is a corrupt, establishment Democrat that consistently puts corporate interests over the people's needs on the most crucial and pressing issues of our time. He is a quintessential example of why increasing numbers of people are losing confidence in the Democratic Party and why the Democratic Party is increasingly losing to Republicans (who get even more money from big corporations). The Democrats have historically depended on the support of working-class people, but, it turns

Follow the money

Denny Heck's campaign finance information reveals who he really represents. This information is easily accessible thanks to the website opensecrets org. What really stands out is that his largest source of funding, over \$500,000 comes from the banking finance, and insurance

industries. It is also notable that 78% of his total PAC donations come from business interests vs. 18% from labor and only 4% from single issue groups.

sentatives like Bernie Sanders and Pramila Jayapal, the newly elected representative from Washington's 7th District. Jayapal's largest sources of funding come from single issue groups and labor, and she gets comparatively less from banking and insurance. Only 4% of Jayapal's PAC funding comes from business groups, while 62%

comes from labor and 33% from single issue groups.

Selling out the people


So, what do all these campaign finance dollars buy for the corporate interests bankrolling Heck? The an-

swer is, they buy them a congressman who will vote for corporate interests over the people's interests on a consistent and ongoing basis. Denny Heck has sold the people out ing defense spending at the expense of social services, for arming groups in Syria fighting to overthrow the Syrian government, for at least three banking deregulation laws, in an early vote



to the corporate interests on a wide range of critical issues. He has failed to support progressive bills in Congress that would enact Medicare for All, cre-

ate a \$15 per hour living wage, reduce mandatory minimum prison sentences for nonviolent and drug offenders, increase social security benefits to keep up with the cost of living, stop the US from providing arms to terror-

ist groups in Syria, end marijuana prohibition, renegotiate NAFTA to include stronger envi-

ronmental and labor rights standards, and strengthen worker's rights to recover lost wages and increase penalties for wage theft among other important progressive measures.

During this same time, he has helped to enact a number of regressive

laws. He voted to reduce food stamps by \$8.7 billion, to expedite natural gas exports from fracking, in favor of federal subsidies for fossil fuel research and development, for building more nuclear weapons, against a 1% reduction in defense spending, for expandin favor of fast track trade agreement approval (though he later changed his position), and for huge corporate tax breaks at the expense of social services.

Denny Heck's town meeting

In a recent Town Meeting, Denny Heck was challenged by a number of his constituents on a few of these issues. Before the meeting, some of us handed out flyers listing many of Heck's anti-progressive votes and positions.

Medicare for All

One audience member asked why Heck was not supporting the Medicare for All bill currently in the US Congress. With 93 representatives now cosponsoring it, which is almost half of all Democrats currently in the House,

disingenuous. His documented votes speak for themselves. I also brought up his failure to support the Stop Arming Terrorists Act, a bill, introduced by progressive Congresswoman Tulsi Gabbard, to stop the US from providing arms to al Qaeda and other terrorist groups in Syria who are fighting to overthrow the government. He did not respond to this at all.

Campaign financing and corruption


Tamborine Borrelli, a progressive "Berniecrat" who has stepped forward to run against Denny Heck (see below), asked Heck whether he thought his source of campaign funds affected his decision making. He said he believes he represents the people well and, "he sleeps well at night." Unfortunately, the same probably cannot be said for the thousands of Muslim children living in endless war, or people with serious medical conditions and no health insurance, or those whose water has become unsafe due to fracking.

Time for progressive change

Unseating Denny Heck and electing a real progressive representative who refuses to take corporate money will not be easy. It would be an extraordinary political development. But are we not in extraordinary times? From growing inequality to grotesquely bloated prison populations, unchecked climate change to endless war, the crises we face are real, the human suffering is genuine, and the situation is continuing to get worse. The success of the Bernie Sanders campaign needs to be our wake-up call, and the election of Trump our snooze button. The majority of the American people are frustrated with government and thirsty for progressive change. But for people power to beat corporate power,

we will need more than having public opinion on our side. An organized mass movement will be required. We will need tens of thousands of small donations and thousands of people stepping up to help with a campaign. We must mobilize the progressive majority in our district and get them to vote in the Primary election in August, 2018.

this bill has substantial support. But Heck refuses to support the bill. Could it be because his largest single source of campaign funds comes from the insurance industry which gave his campaign more than \$100,000 in 2016?

Heck's justification for not supporting the Bill is that it has several flaws and is not "fully formed." Even if this is true, he did not say that he would support Medicare for All with some improvements or whether he supported the idea of single payer healthcare in general. He did not offer an alternative vision for how we are going to make sure everyone has full access to complete, high quality health care which is a basic human right in modern society. His focus, he said, was solely on preserving Obamacare.

Regime change in Syria

I challenged Denny Heck on his votes in favor of regime change in Syria and asked why he was supporting the regime change war. He has voted at least two times in favor of bills to authorize the CIA to arm and train groups fighting to overthrow the government of Syria. This policy has played a major role in fueling the horrific war there. His response was that I "misconstrued" his votes and that he opposes regime change. But this is

Bernie Sanders: Pied piper for the **Democratic Party**

Bernie Sanders' call for a 'political revolution' against the establishment brought out over 12 million supporters who voted for him in primaries and caucuses. I joined his campaign in January 2016 and left on the day he publicly endorsed Hillary Clinton. What he didn't make clear to most of his new followers throughout his campaign was that he had always tipped his Democratic Party establishment -Clinton, Gore, Obama-and 2016 would be no different.

Once Bernie endorsed Hillary, his supporters had several choices. The millennial neighbor I had recruited to help lead my precinct caucus tore up her t-shirt and sign and threw them in the garbage. Most of those who remained active followed Bernie's lead. They stayed in the Democratic Party to fight to change it from a neoliberal party controlled by corporate/wealthy donors to a 'party of the (working) people.' They are the 'Berniecrats'. In Thurston County, Berniecrats

took over the local Democratic Party in December with the election of new officers. Key leaders of Thurston Progressives, formed after the primary, helped with the "takeover" but their group includes independent members. Greens, Democratic Socialists and progressive movement activists of all types participate with Thurston Progressives in local committees focused on various issues. Locally there is one bright light of principled independence on the horizon: Tamborine Borelli, who was a national Bernie delegate, has joined the Green Party and recently announced that she will be running as an independent against the DP incumbent, Denny Heck, for Congress in 2018.

Nationally, Bernie's supporters didn't all become Berniecrats. Some

joined the Green Party or stayed loosely aligned with various outgrowths of the campaign: Progressive Independent Party (PIP), Brand New Congress, Justice Democrats, Our Revolution or 'Draft Bernie: For a People's Party'.

PIP hopes to unite the Progressive groups that are independent of the Democratic Party. PIP seeks to bring all the disparate Independent forces together occasionally for 'Progressive Unity Summits.' Summit1 occurred on January 22nd in Philadelphia, the day after the post inaugural women's marches. Summit2 is scheduled for August 18-20 in Seattle.

The Brand New Congress (BNC) has the goal of replacing the entire congress by running candidates against establishment incumbents in 2018 and beyond. They are working with the Justice Democrats (JD) in this effort. BNC came out of the Berniecrat movement and JD came from Cenk Uygur, founder of The Young Turks and Kyle Kulinski, host of Secular Talk. BNC and JD have raised close to \$1 million to support candidates in the 2018 congressional races.

Finally, Nick Brana, former national outreach coordinator for the Bernie Sanders campaign, founded the 'Draft Bernie for a People's Party! This movement hopes to win Bernie over to lead that effort, a fairly long shot given Bernie's 25-year history of working inside the Democratic Party.

The eco-terrorists among us

The fossil fuel industry and the distortions of language and justice

When I use a word," Humpty Dumpty said in rather a scornful tone, "it means just what I choose it to mean — neither more nor less."

"The question is," said Alice, "whether you can make words mean so many different things."

The duplicities of capital

If Alice from Through the Looking Glass could see Sean Spicer's daily verbal contortions, she probably would think of him as Humpty Dumpty's reincarnation, equally scornful, but in a less talented presentation. The White House press briefings conducted by Sean Spicer constitute the distressing quotidian proof of how those in power try to control the communicative process in American society by distorting facts and meaning. As Press Secretary, Spicer's main role is not to disseminate the truth, but to construct narratives that fit the political interests of this administration and its wealthy allies.

At the same time, Spicer is an example of how capitalism isn't limited simply to the reproduction of exploitative relations of production in a given society (i.e. the economic apparatuses, located in the places where we work, which are owned primarily by a minority of capitalists who are also the main beneficiaries). Capitalism is also interested in reproducing the conditions that make possible the continuous renewal of the economic domination capitalists enjoy. In

other words, capitalism is interested in putting into place a series of mechanisms that justify and perpetuate its interests and conditions of privilege. We call these the functions the Ideological and Repressive State Apparatuses (ISA and RSA)

Within the ISA, we find those institutions whose function is to manufacture the hegemonic discourse of the system. They encompass the government at all levels, from politicians to public servants; the judiciary systems; the educational institutions from kindergarten to universities; political parties; religious organizations; and the media in all its forms, etc. In the second group, the RSA, we inevitably find those who operate by the use of violence, such as the police, the army, the courts, prisons, and the large variety of national security agencies. There is a simultaneous acting and organic intersectionality of all these three state apparatuses (the economic, the ideological, and the repressive) which make possible the functioning of the state under capitalism both by consent and repression. To paraphrase John Lanchester from the New Yorker, for capitalism "the desire to make money is sincere, not everything else is."

Pepsi-Cola and eco-terrorism

disobedience group that turned off the valves on four tar sands pipelines last October, are facing felony charges with potential sentences of decades in prison and ten of thousands of dollars in fines. Courts and state prosecutors are actively trying to frame the **shutitdown.org** valve-turning actions as ecoterrorism.

Pembina County Courthouse

A call went into the TransCanada operations center at 9:02 am on October 11, 2016, to warn that someone intended to shut the pipeline down in ten minutes. The op person at TC called their local rep Lonnie Johnson, to report this call. The op center person described the caller as an "eco-terrorist." When TC's local rep Lonnie Johnson called the Pembina County sheriff office, he described the person as a "terrorist." Under questioning, the sheriff admitted that after he arrived at the site of the valve turning, he arrested Sam Jessup even though Jessup was not committing a crime.

Defense attorney: "What facts did you have? (Jessup) was videoing you and the defendant Mr. Foster. He picked up the camera equipment. He was walking on a gravel road."

Language is not neutral. The ideological apparatuses of the state, when facing an oppositional critical discourse, strategically react by assimilating and neutering the dissonant message in order to subsume it into the mainstream narrative of the time.

Language is not neutral. The use of language is part of the greater battle of class and social struggle conducted in the field of linguistics, semiotics, communication and the production of knowledge. The ideological apparatuses of the state, when facing an oppositional critical discourse, strategically react by assimilating and neutering the dissonant message in order to subsume it into the mainstream narrative of the time. For example, in terms of popular culture, we recently witnessed the attempt by Pepsi to increase their sales by appropriating the symbolism of acts of protest and resistance

around the world, including reminiscences of the occupy movement and the Black Lives Matter imaginary in a video-commercial. In this example, political

action is represented back to us, formatted like advertising; rebellion and resistance cease to be revolutionary acts, transformed instead into an act of collective libation of a carbonated soft drink, absorbed and assimilated into consumerism. (The commercial was quickly criticized by viewers and pulled out by Pepsi.)

Conversely, a parallel perverse distortion of language is currently taking place within the Repressive Apparatuses of the State. Many courts, judges, prosecutors, and police departments, acting in coordination with the fossil fuel industry across the nation, have initiated a synchronized campaign of vilifying civil disobedience directed to stop the negative impact on the environment by the fossil fuel industry. For example, members of the **shutitdown. org** campaign, a direct action, civil

Who really are the eco-terrorists among us? Those who profit from its destruction or those who, given the critical conditions of the planet, try to protect it in order to avoid a catastrophic end for humanity

and other species?

Labeling people who engage in nonviolent civil disobedience as terrorists is not fortuitous, particularly in the current political-ideological conditions created by the security state and the U.S. Patriot Act of 2001, which among its numerous provisions seeks

Deter and punish terrorist acts in the United States and around the world, to enhance law enforcement investigatory tools, and for other purposes.

Needless to say, these conditions have been exacerbated by the current Trump administration. Using the language of terrorism is a calculated political move aimed at eliminating any form of dissent against the fossil fuel industry and its nefarious relationship with nature. It intends to suppress criticism against those who simultaneously appropriate the products of soci-

ety and nature, subjugate the labor of others, and endanger the planet and society by means of that appropriation.

Contrary to the symbolism usurped by the Pepsi commercial, the videos posted by **shutitdown.org** clearly show older, middle aged and younger civil activists shutting down the emergency valves on pipelines in Washington, Montana, Minnesota, and North Dakota. According to The Nation (Feb.13-2017), through this action, the valve turners "successfully shut down the flow of tar-sands oil into the United States from Canada". The shutitdown. org videos create images and symbolic acts difficult-although not impossible—to be directly assimilated and absorbed by the cultural illusions of the media. Consequently, for the time being, these actions are being are dealt with directly via the Repressive Apparatuses of the State, its laws, its courts, its police departments, and its prisons.

The future may not last as long as we expect

A brief overview of the forms of economic development since the second half of the 20th Century—a period known as The Great Acceleration—shows the perverse impact of capitalism on the planet. The great majority of scientists agree that we no longer live in a geological time period determined by the earth's natural processes. Rather, this moment in geological time is one that has ultimately been conditioned not by nature but by human agency. We live in the Anthropocene.

The critical situation posed by the Anthropocene has created a sense of historical immediacy related to the survival of the human species. Nonetheless, our scenario is complicated by two factors: first, the business-as-usual mentality of capitalism in general and the fossil fuel industry in particular, which persist in -let's call them what they are—terrorizing and irresponsible practices against the planet and life on earth. Second, new conditions of interdependency between nature and culture, are taking place within a never-before experienced dis-alignment between nature's time scale, and human time; between geological and

political time. This misalignment creates for many people the false impression that we have plenty of time ahead to solve the current ecological crisis. Yet, evidence suggests that the future may not last as long as we expect.

Consequently, it's time to act, time to address the current historic-geological conditions of emergency with a sense of urgency, fueled by a sense of the morality in our actions. This is precisely what the 'valve turners' of Shutitdown.org are doing. The State, on the other hand, uses language to deliberately distort reality, misrepresenting nonviolent activists as eco-terrorists and absolving the real culprits. Justice is distorted as the prosecutors for the state protect those who actions endanger all of us, and persecute those whose actions threaten private profit.

As Sam Jessup's parents, and as people who appreciate the high-risk, well-organized, and much needed direct action aimed at keeping fossil fuels in the ground, Emily Lardner and Enrique Quintero plan to be present at the trial of Sam and Michael Foster, currently scheduled for October 2-6 at the Pembina County Courthouse.

The need for Radical Progressivism

"We must be willing to make fundamental changes"

I have been running ragged lately. I work a full-time job that has a lot of surprise overtime. I have activist projects and now a partisan position as well. All of these things are different, but I view them as interrelated. We are facing a humanist crisis and have been for some time. I can't mollify

my anxiety with cool reason as it too compels me to do all I can, more than I should, to stay stable. If there ever was a time to throw oneself onto the gears, it is now.

Currently, our lives are being commodified and measured according to our respective abilities to pro-

duce labor as well as how monetarily validated that labor can be. We have been codifying classes based on their members' ability as well as their appearance, beauty, whiteness, thinness, extroversion, charisma, and ability to maneuver gracefully within the social paradigm matrix (which is sometimes referred to as the Kyriarchy). This matrix was not set up by any one individual, and there is no unified managing body that enforces it. Rather, it is produced by market forces, law enforcement, the government, and social power figures and groups. These all affect each other and the bodies around them almost as if they were interstellar bodies swaying with gravity through the void.

bodies effect each other as well. The sun's heat and light enables life on our planet. Jupiter's gravity well protects Earth from foreign astral bodies, like asteroids, that could destroy that life. But this balance is tenuous. It is also, seemingly, singular. How many other solar systems have we found that have intelligent life? How many have even the potential for life on any poisonous,

ate they become.

There is also the urgency of global warming and drastic climate change. It will be here within 100 years if not even sooner. There will be eight feet of sea-level change which will mean millions of dollars in damage or construction. Not only will there be local displacement, but, understanding that our bioregion will be one of the least effected, many of those displaced from far away will be refugees heading here. We have declared Olympia a sanctuary city, but what will happen to the refugees of Californian desertification? Will they have sanctuary here? Currently, homelessness and survival are both criminalized while the majority interests in local lawmaker decisions seem held up by New Left capitalism. Gentrification and new condos are favored. The wealthy know a smart investment, and they are seeking to put a strong hold in before it fills up with the displaced poor.

We need change, big, radical change, and we need it to support even the

least of us. A lot more of the tired and poor are coming. These huddled masses yearning to breathe free, clean air, the wretched refuse of a teeming American shore, more homeless, more tempest-tossed are coming to our state, our city, and many will come with nothing but what they could fit in their car, boat, or backpacks. Many of us long-term residents in this city, will be displaced by construction to prevent climate change damage or by the effects of climate change itself.

We need heroes who can think dynamically, come up with effective and fair solutions, and do what must be done to ensure a better tomorrow. Our humanity is being put to the test now. We have crossed the threshold into climate change. What we do today and each day thereafter will make or break our future.

Furthermore, say that it is your patriotic duty to let others know of her/ his/their activities and how you won't


stay silent on what's wrong with this country, the government, and the DNC (and its campaign neo-McCarthyism). Tell her/

The needs of Syrian people come

The evidence has continued to mount that the Syrian Air Force dropped Sarin gas on Khan Shaykhun in Idlib province in Syria on April 4th, 2017 killing at least 80 people and seriously wounding hundreds. Evidence

includes eyewitness accounts, statements by doctors and other medical personnel in Turkey who treated the wounded, statements by various scientific organizations that it was Sarin gas dropped from the air, the past use of Sarin by the Assad regime in 2013 gas and the implausibility and obvious falsehoods of the Russians and Syria's President Bashar al-Assad about the attack. It is disheartening that so many on the left deny that Syria did these horrific killings or say we have no idea who did it. Although there is close to but not 100% proof of the Syrian government carrying out this horrendous attack, I fear that those who deny or cast

doubt on Syrian government responsibility would not accept any evidence that challenges their preconceived notions and ideology.

I also disagree with many people who reduce Syria and the war there to geopolitics and begin and end their position by being opposed to any U.S. military intervention in Syria. The arguments against U.S. military intervention in Syria and other countries are very strong but they are not absolute nor is the U.S. the only aggressor in other countries. The U.S. is the major aggressor globally and given that we live in the United States, it is our main responsibility to oppose our interventions. Nonetheless, for people or organizations, which are committed to global solidarity, we should not ignore extreme oppression and repression of people in other countries. This is not saying the United States government should intervene militarily but that we, the people, should carefully examine what is going on and consider ways that social movements can be in solidarity with democratic and left struggles; that intervention although almost always wrong is not an absolute.

My starting point in thinking about Syria and suggesting actions and demands is the needs of the Syrian people, realizing they are important differences among Syrians. We should ask ourselves if there is anything that can be done by people in the United States or that we can demand of the U.S. government to reduce their suffering and increase their possibility for justice and peace? With a quarter of the Syrian population refugees in other countries, desperate enough to risk their lives in transit and knowing that they are usually not welcomed

in the countries they seek refuge in. Another quarter are internally displaced by the war and at least 250,000 Syrian civilians have been killed since 2011. According to the Syrian Network for Human Rights, http:// SN4HR.org, a credible source, 90% of the documented deaths of civilians in Syria since 2011 have been caused by the Syrian government or by the



Russians bombing in support of Assad, i.e., I am excluding Russian bombing attacks on the Islamic State. The Syrian regime is an extremely murderous government. As I will explain below, I do not support increased U.S. military involvement in Syria but that should not be the starting point of the analy-

I have no tolerance for those who visit Syria for a week at the invita-

tion of Bashar al-Assad and come back praising his government or talking about the liberation of Aleppo in December, 2016 or Syrian stability. What kind of stability is there with half of the population displaced, with torture as state policy, with 13,000 people put to death in Saydnaya prison alone, https:// www.amnesty.org/en/ latest/news/2017/02/ syria-investigation-uncovers-governments-secret-

campaign-of-mass-hangings-and-extermination-at-saydnaya-prison/. For those who claim Bashar al-Assad is an anti-imperialist, why did he work closely with the George W Bush administration to torture prisoners that the U.S. sent to Syria such as Maher Arar in 2002. The enablers of the al-Assad regime deny the democratic uprising in Syria in early 2011 that was met with murder, torture and repression by the Syrian state and the subsequent increasing militarization of the opposition to Assad. It is false that outside arms and intervention by the conservative Gulf States caused the Syrian government's attacks on its own people; their military intervention followed. As the struggle got increasingly militarized the Gulf States including Saudi Arabia, also Turkey and the United States have gotten increasingly militarily involved but on a smaller and less lethal level than the Russian, Iranian and Hezbollah alliance with the Bashar al-Assad regime. This is another rewriting of history; they deny the mass uprising

> in 2011 of the Syrian people in order to claim the murderous rule of the Syrian government is a response not to a popular uprising but to invasion by outside countries and local and foreign jihadists. A related reason that we are supposed to accept the Assad regime is that we are told that they are the only alternative to the Islamic State and other jihadist groups such as al-Nusra. Assad and the various jihadist groups are both horrible alternatives but this also denies any agency of the Syrian people including the struggle in the mainly Kurdish area of Rojava for autonomy and self-governance, led by the PYD/YPG. Although weaker

than in 2011, opposition to the Assad regime and the jihadist organizations continue inside Syria and by Syrian

The United States military attack of the Syrian airbase

On Friday morning, April 7th, 2017, the United States military attacked the Shayrat Airbase, where the Syrian Air Force planes that bombed Khan Sheikhun in Idlib province had left from

> sand Syrian civilians since the fall of 2014. This April 7th bombing was the first U.S. bombing directed against the

Assad regime. Also and even more important, why do these enablers of Assad not show outrage at his massive killing, wounding, torture, imprisonment, disappearance and displacement of Syrians?

It is clear that the Trump administration has no concern about the lives of Syrians, for example his barring from the U.S. of all Syrian refugees. Note also Trump's further loosening of restrictions on the killing of civilians by U.S. bombing in the Raqqa region of Syria. In Syria and Iraq, U.S. bombing is killing even more civilians than under Obama. The attack on the Syrian Air Force base on April 7th was most likely an attempt by Trump to gain popular support in the U.S. by demonstrating that he is a decisive leader, to divert attention from his administration's daily attacks on the people of the United States and the environment and to demonstrate that he is independent of Putin and Russia. Just a few days before the Assad's regime use of nerve gas, two of the leaders of the Trump administration said they could live with Bashar al-Assad as the president of Syria, which may have further encouraged Assad to use Sarin. Demonstrating his hypocrisy and instability, Trump strongly denounced any possible use of military force by President Obama in 2013 when Syrian military use of Sarin killed 1300 people in Eastern Gouta, near Damascus. I am against further escalation of the war by the United States in Syria as it likely to increase Russian military involvement, to increase the number of Syrian casualties, possibly increase support for Assad, and finally, any Syrian leader and government put in power by the United States will probably be another repressive and oppressive one with the likelihood that the Syrian security state apparatus will continue.

The Trump administration is a very dangerous one for the people of the

United States and the globe and its actions must be strongly resisted. However, we cannot reduce U.S. military involvement and war only to its intent; we must also consider the likely outcome of its actions. For example, it was right to critically support the U.S. war against fascism in World War II, although its reasons for

entering the war were not primarily to save the Jews, Roma people and others from extermination. Much of the criticism of the recent bombing of the Syrian air base by the Trump administration criticizes correctly its motives. The United States government is also using a double standard when it condemns Syria for using chemical weapons when it used them on a much larger scale against Vietnam. Still, if increased U.S. military involvement in Syria would bring peace and the possibility of economic and social justice to Syria, I would support it. However, U.S. military escalation against the Assad government is likely to only further Russian escalation against the Syrian population, thus increasing casualties and not bringing Syria closer to peace.

The United States bombing of the Syrian Shayrat airbase will not reduce the killing and destruction caused by the Assad regime and his allies. may make President Assad hesitate to use nerve gas again but even that is not definite and the barrel bombs. torture, disappearances, hunger and deaths will continue.

three days earlier. The United States attacked with 59 Tomahawk Cruise missiles, killing according to the Syrian government six or seven people, two of whom were civilians. I do not support this April 7th bombing by the United States although I find very hypocritical those in the U.S., who are horrified and continually denounce this recent bombing while not strongly opposing the 8000 bombing attacks that the U.S. has launched in Syria against the Islamic State and other opponents of Assad, killing a few thou-

President Trump's "targeted reductions" and our Thurston County communities

A Preliminary Report

Dan Leahy

The core of my first Budget Blueprint is the rebuilding of our Nation's military without adding to our Federal deficit. There is a \$54 billion increase in defense spending in 2018 that is offset by targeted reductions elsewhere. – President Donald Trump. (America First: A Budget Blueprint to Make America Great Again, March 16, 2017, page one).

I reviewed President Trump's Budget Blueprint. Part of his proposed "reductions" to shift \$54 billion to the military, are eliminations. I noted and "charted" all the independent agencies marked for elimination and all the programs marked for eliminations. These eliminations do not include other proposed budget reductions.

I then began to ask local governmental agencies, non-profits and unions in Olympia and Thurston County what these eliminations might mean to our communities. So far, I have barely scratched the surface of the implications of these eliminations. Thanks very much to all those people who responded to my requests for information

Community Services Block Grant

Elimination of the Community Services Block Grant (CSBG) of the Office of Community Services of the Department of Health and Human Services, a targeted reduction of \$4.2 billion dollars

Senior Services of South Sound, operating out of the Olympia Community Center, depends on federal funding from CSBG from the Department of Health and Human Services, as well as other federal sources. The proposed 17.9% cut in funding for this Department would mean a loss of \$73,829 dollars for Senior Services. This would force a decrease in meal service to seniors, a closure of two or three rural meal sites, 800 fewer meals/month for 100 seniors and the need to begin a waiting list for new Meals on Wheels clients.

National Endowment for the Arts Elimination of the National Endowment for the Arts (NEA). NEA distributed \$5 billion in 128,00 grants between 1965 and 2008. It had a \$146 million dollar budget in 2015.

Some of the recipients of NEA grants via the Washington State Arts Commission (Arts WA) in Thurston County over the last several years include: Tenino and Yelm School Districts, Harlequin Productions, Rachel Corrie Foundation, Student Orchestras of Greater Olympia, Ballet Northwest, Masterworks Choral Ensemble, Olympia Film Society, Olympia Chorale Society, the Evergreen State College Foundation and the Washington Center for the Performing Arts.

Corporation for National and Community Service

Elimination of the Corporation for National and Community Service (CNCS). With a budget of \$1 billion dollars (2013) and 485 staff (2006),

Proposed program eliminations by federal department

On March 16, 2017, the Office of Management and Budget released President Trump's document entitled, "American First: A Budget Blueprint to Make America Great Again." In the chart below, I've listed by federal department those programs that this budget has identified for elimination. These eliminations totally \$54 billion dollars is intended to offset the \$54 billion dollar increase to the Department of Defense.

CNCS engages five million Americans via AmeriCorps, Senior Corps, VISTA & US Freedom Corps.

In an April 13, 2017 letter addressed to member of Washington State's Congressional delegation, Tumwater Pete Kmet wrote the following about the importance of the CNCS to Thurston County:

In Thurston County, specifically, the five AmeriCorps services are performed across the cities of Olympia, Lacey, Tumwater and Rochester. These services are performed by 121 AmeriCorps members at 67 sites, representing five distinct programs. These programs are Community

Youth Services, Vet Corps, Washington Conservation Corps, Washington Reading Corps and Washington Service Corps.... The total value of these services is over (\$) 25 million." The Mayor continued, "If the CYS (Community Youth Services) Youth in Services program was discontinued, 650 youth and families would not receive individualized educational and life skills support.

The elimination of this program

would mean no more AmeriCorps volunteers for these programs: Big Brothers and Big Sisters, Boys and Girls Club, Center for Community-Based Learning and Action, Crisis Clinic, CYS' Rosie's Place, Family Support Center, Mercy Housing, Pear Blossom Shelter, ROOF Community Service, South Sound Reading Foundation, Thurston County Food Bank, TOGETHER and YWCA- Girls without Limits.

Loss of CNCS funding would also mean no more AmeriCorps volunteers for these schools: Garfield, Hansen, LP Brown and Madison elementary, Olympia High School and Wa He Lut Indian School.

Department of Labor's YouthBuild

The elimination of the Department of Labor's YouthBuild program at Olympia's Community Youth Services would eliminate the workforce for these completed affordable housing projects: Homes First (Tumwater), Emanuel Lutheran Church (Yelm) Disaster Preparedness Center, Habitat for Humanity (Lacey) storage sheds and fencing for a 30 unit housing development, Panza storage shed for 24 unit homeless adult community, Veterans Assistance Fund (Yelm) Tiny Home for a homeless veteran.

The elimination of the National and Community Service and Department of Labor funding at Community Youth Services of Olympia would mean a \$1.4 million dollar decrease in its budget.

Legal Services Corporation

Elimination of the Legal Services Corporation (LSC). With a budget of \$375 million (2015), the LSC is the largest single funder of civil legal aid. It distributes 90% of its funding to 134 independent, non-profit legal aid programs.

Here in Washington State the Legal Services Corporation funds the Northwest Justice Project (NJP). NJP works with clients by challenging institutions and practices that disproportionately affect low-income communities and perpetuate poverty. It's main office is in Seattle with 17 offices around the state including one located here in Olympia. In 2015, NJP celebrated its 20th anniversary. In the same year, NJP closed 14,858 cases, helping 32,987 individuals including 14,546 children, 2,605 seniors and 1,642 veterans. The Olympia office closed 205 cases last year in the areas of public housing, domestic violence, return of drivers' licenses, and termination of public services.

The Community Development Block Grants

The elimination of Community Development Block Grants (CDBG)—a program of the Department of Housing and Urban Development—will mean a "targeted reduction" of \$3 billion dollars

Olympia is the only city in Thurston County that receives CDGB grants directly from the federal government. It does not receive CDBG grants via Thurston County. The City receives approximately \$350,000. Federal CDGB funds have provided: training and coaching of small business entrepreneurs, acquisition of derelict buildings (e.g, Griswold's), Alley lighting and ADA sidewalks, trash compactors for solid waste, and the downtown Ambassador program.

Thurston County became a direct CDBG recipient in about 2007 when it reached the 200,000 population threshold and thus became an Urban County. In 2015 and 2016, the County received about \$1.1 million each year in CDBG Grants. In 2016, CDBG grants help fund a Bucoda water line repair (210K), a Yelm Splash Park (\$305K), a single family repair via Habitat for Humanity (\$272K), and Tenino Boys and Girls Scholarship (\$81K).

The City of Lacey, like all cities in Thurston except Olympia, receives

The "insane and dangerous" campaign

In late January, Glen Ford of the Black Agenda Report was interviewed on The Real News Network. In response to the question of his thoughts on the transition to the Trump administration, Ford stated the following:

"I think that, to the extent that this outpouring of anti-Trump sentiment is also all caught up and all tangled with the Democratic Party's insane and monstrously dangerous pro-war and anti-Russian propaganda campaign, that it is actually poisoning the well for any progressive movement under a Donald Trump presidency.

"So I think we should be very clear. There is no such thing as a progressive movement that is also pro-war. And there is no such thing as a progressive movement that is aligned with the CIA. And yet, that is exactly, exactly the position that the Democratic Party is taking, including its black lu-

minaries, such as Congressman John Conyers, and Congresswoman Maxine Waters, and even Congresswoman Barbara Lee, who is considered to be the most left-wing person on Capitol Hill. All of them are busy attacking from the right, the very right-wing president, Donald Trump. And any fool should know that countering right-wing politics with even more right-wing politics can only lead to a disastrous and definitively right-wing result. You cannot create a progressive movement out of a McCarthyite, anti-Russian, pro-war propaganda campaign such as the Democrats are waging now and in which they have now enlisted the support of lots of people who call themselves progressive. And even some who consider themselves to be radical.

"Any movement that takes its cues from the CIA is a danger, not only to world peace, but it is a danger to itself. It's a danger to the very civil liberties that a progressive movement claims that it's trying to defend from the likes of Donald Trump. And, frankly, it's just plain stupid and it's stupid in a very peculiar and very American imperial kind of way."

Should there be a Tea Party movement on the Left?

It has been mentioned that progressives should consider creating something similar to the conservative Tea Party. Articles have been written, suggestions made, and lists of the successes of the Tea Party in revitalizing and pushing the Republican Party to a more conservative position. In an interview in Monthly Review Magazine, Anthony DiMaggio of author of The Rise of the Tea Party: Political Discontent and Corporate Media in the Age of Obama (lauded by McChesney, Chomsky, and others) revealed the unpleasant reality of the Tea Party. Below is a list of his main points.

• "This is the dirty little secret of the

Tea Party; it's not really a social movement, but a cluster of elitist interest groups operating locally and nationally variety."

- The Tea Party has failed "to systematically organize at the local and national level... Very few people actually turn out for rallies and planning meetings, compared to the large number of people who claim to be participating in these events according to national polling data."
- The leadership in Tea Party groups comes "from the highest levels of local and national Republican Party chapters and the business system."
- "The alleged Tea Party 'insurgents'
 who have led the Tea Party 'revolution' in Congress are extremely
 elitist in their policy positions and
 in terms of their economic backgrounds and their voting records
 are identical to non-Tea Party Republican members of Congress."
- The Tea Party organizers were largely autocratic, only interested in directing the agenda from the top down, with the help of local "Tea Party" candidates, who were really just Republicans running for office.
- Their primary goal was returning a largely discredited and extremely unpopular Republican Party to power, contrary to the public rhetoric of the Tea Party that the "movement" had "nothing to do" with partisan politics.
- "This 'movement' is—for all intents and purposes—a mile wide and an inch deep.

DiMaggio suggests that, instead of considering the Tea Party as a template for response, those on the Left should revisit Occupy Wall Street (OWS). He described OWS as having "Greater transparency in the political process" with expectations that "political officials make serious efforts to promote the common interests of the American public over expansive corporate power." He stated that the public needs to "redirect their rage in more productive ways. Unlike OWS, DiMaggio recommended that new efforts "will need to develop a far more specific agenda with regard to how we will move forward in promoting a more democratic future..." as well as "a set of demands that are separate from the corporatism being offered by the Democrats" He goes on to say that the "general rage" directed against Trump and his administration "is a good start, but it won't get you very far."

The DNC vs. Gabbard thing

"Identity Politics" as the scapegoat for 2016 Democratic Party defeat

The first two weeks of the Trump presidency ought to be engraved in our memories as if in granite. Politics is a blood sport and the far right takes no prisoners - except, apparently, those it intends to torture. The Republican Party has demonstrated for a very, very long time now that it has no use for a single one of the niceties of bipartisanship. Yet most Democratic politicians dib and dab around as though living in a different political

We are witness to three simultaneous crises: a crisis of the working class, which is fractured by race, by region, by citizenship status and, increasingly, by religious belief, and which lacks political cohesion or organizational representation. A crisis of the ruling class, which was bullied and backed into a corner by a megalomaniacal kleptocrat who stole their candy and who has no respect for the core institutions of class rule or for the stories his class brothers and sisters tell each other about the delights of the prevailing world order. A crisis of the state, in which far-right ideologues, autocrats and theocrats, having captured the governing apparatus, are rapidly concentrating power in the executive while bureaucrats scramble toward either dissent and defiance or appeasement and accommodation.

A highly consequential debate about the future direction of the Democratic Party rages among academics, pundits and politicians. This debate is most active among liberals, but it ranges both rightward and leftward as well. For two months now liberals have been ruminating on the role of "identity politics" in November's defeat of Hillary Clinton. Essentially the debate turns on whether the Democratic Party and Clinton, in their embrace of racial, religious and sexual minorities, forsook working class whites, who responded by casting their votes for Trump. According to this point of view, the journey back from the devastation of 2016 requires that the party take an indefinite break from identity politics to concentrate on winning back economically squeezed white workers. There's a leftish version of this line - an economic fundamentalism that posits that pocket book issues trump all others. And a classic liberal version that, seemingly reasonably, demands the subordination of the part to the whole, the interests of particular groups to the national interest. Both boil down to the same thing: it's time to subordinate the rights claims of various "interest groups" to an economic agenda that prioritizes the distress of white workers. Only this adjustment will create the conditions for Democrats to make gains in

congressional and statewide races and to retake the White House in 2020. (Or, in the leftish version, only this adjustment will set the foundation for building a successful workers' movement.)

Where will the Democratic Party

The degree of traction this postelection analysis gains will, at minimum, impact the direction of the flow of attention and resources of the party, liberal think tanks and liberal philanthropy, as well as the focus of progressive organizations. It will likely determine how the Democratic Party positions itself relative to 2018 and 2020, and whether that positioning has the intended effect of creating a sufficiently broad electoral coalition to roll back Trumpism. With the tenor

and thrust of liberal and left politics hanging in the balance, it is worth taking a moment to examine what might be problematic about analyses that lay 2016's rout of the Democratic Party at the feet of "identity politics.

It's never a good idea to enter willingly into a frame your opponent has constructed to entrap you. The last I heard, "identity politics" was the terminology of the right, deployed to disparage and dismiss social justice movements that seek to expand the democratic rights of marginalized and excluded groups. Implicit in the term is the notion of placing the concerns of of selfishly advancing narrow, particularistic agendas rather than the broader national inter-

The terminology of "identity politics" is part of a whole vocabulary including "thought police," 'politically correct," and "liberal elites," whose main intention is to undermine the legitimacy of liberal and left politics. In my experience, advocates and organizers for racial justice don't think of themselves as purveyors of "identity politics." Nor do immigrant rights organizers, advocates for LG-BTQ rights or women's rights activists. Rather, in fighting for the expansion of democracy for particular groups they rev the motor for the renewal and expansion of democracy for the whole. And they know from experience that purportedly universalistic solutions often work to make already embedded inequalities even more rigid.

Uncritically adopting the "identity politics" language of the right is the equivalent of dropping our guard and waltzing onto their terrain. Master's tools, master's house anyone? We need to recognize a toxic frame when we see one and refuse to be a party to its proliferation.

One could go on, but who really wants to track back through the catastrophes and follies of U.S. national formation perpetrated, in substantial part, the name of whiteness? This is not about projecting the racial sensibilities of today back onto social and political environments that operated on completely different sets of assumptions. It is about reckoning with the degree to which the nation-building project has been, at the same time, a white identity formation project. This fusion of white identity and American identity, the bedrock of white nationalism, has such a long history that it has been internalized and naturalized. Only since the Civil Rights movement has it began to be somewhat

disrupted. Until we collectively "get" this, some will continue to deny or be confused by the white rights subtext of "Make America Great Again," and surprised at how powerfully it resonated. The shaping of white identity, is a central thread in the national narrative, bound up with capitalist development or another, to one degree or another, in every political, social and cultural insti-

Which brings us to an essential difference between white identity and the identities of groups forged in the experience of exclusion and subjugation. There is a reason that "Black Power!" and "Brown Power!" reverberate on completely different frequencies than "White Power!" And that "White Lives Matter," or "Blue Lives Matter," or even "All Lives Matter" are misguided rejoinders to "Black Lives Matter." An assertion of existential urgency by the marginalized and scorned cannot simply be inverted without carrying the connotation of both a rebuke to demands for justice and inclusion and a reassertion of the primacy of white lives.

> is, obviously, a resurrection of the never-far-from-the-surface characterization of Blacks as sub-human, primitive, uncivilized. These may seem like extremes of a coarse, atavistic racism - a good distance from current concerns about implicit bias and micro aggressions. And no morally grounded person with an interest in reinforcity wants to spend much time contemplating such racist poison. But the point here is that the extremes of anti-Black racism still find a hearing among a substantial segment of white


inforcing the exclusivity of the claim of whites to the national identity now prowls the Oval Office. He of multiple Eastern European wives knows full well that the son of a Slovenian will never be subject to challenges as to his national identity in the way the son of a Kenyan was.

This take on white identity is blunt and broad. It doesn't take into account class, gender, regional variation or the infinite expressions of identity at the level of the individual. Nevertheless, Trump's victory is virtually incomprehensible without a reading on the dynamics of white identity and national formation. The liberal inquiry into the role of "identity politics" in Clinton's loss is pointed in a direction diametrically opposite to where it might find some answers.

The back and forth among pundits over whether Trump voters should be tagged as racist has been especially frustrating. Allegedly, some voters claim that they chose Trump despite his racism and misogyny, not because of it. Or there's the view that all these voters couldn't possibly be racist, because, back in 2008 and 2012, Obama won many of the same overwhelmingly white counties that Hillary lost in 2016. But a majority of white voters cast their ballots for a man who is furiously and floridly racist, and they are premised on exclusion, apparently thrilled that he won. Black Americans standing on the planet today are here due to the vigilance of forebears, close in and long gone, who were keenly attuned to the lethal conin general and man-sequences of white fury. While there's ifested, in one way surely room for debate about the misuse or overuse of the language of "privilege," it does seem a signal marker of white privilege to doubt or minimize the racial animosity of Trump's base.

The national interest equates to white interest.

The conflation of white identity and national identity ripples out into the further conflation of white interests with national interests. In the current debate about "identity politics," this takes the form of maligning Black politics, feminist politics, LGBTQ politics, etc., as fragmentary and divisive while, evidently, a politic built on the economic woes of white workers would be unitary and representative of national interests. There are so many things wrong with this view that it is hard to know where to begin-not least the howling hypocrisy of the sudden attention to the plight of white workers whose precarious economic status has been decades in the making. But to note just two issues, we have here a problematic conception of U.S.



White identity and nation building.

But let's set aside the questions of language and framing for a moment. Because there is, in fact, an expression of identity politics core to the evolution of our nation and critical to how we understand the current juncture. White identity and nation building have been bound together as though co-terminus since way before the founding fathers and the drafting of our framing documents. The rest of us have had to fight our way into the body politic. Or, in the case of Indian nations, make the best of a spectacularly unequal and uneasy standoff. The conceptual contrast between white Christians and red savages underwrote relentless territorial expansion and genocide. Between white Christians and Black savages, the

Fishburn enters race for **Olympia Port Commissioner**

Bill Fishburn, 47, of Rainier, has formally announced that he is challenging Port of Olympia Commissioner Bill McGregor for his District 2 seat. He made the announcement in front of a group of community members active with port issues at a meeting on Sunday night in downtown Olympia. About 35 people were in attendance.

According to the Washington State Public Disclosure Commission, Mc-Gregor has raised \$24,600 to date for his reelection campaign. The filing deadline for the position is May 19.

For Fishburn, the decision to run wasn't rocket science, but luckily, he is a rocket scientist, having received his bachelor of science in aeronautics and astronautics engineering from the University of Washington, and his master of science in mechanical engineering from University of California, Berkeley. Employed for 21 years with the Intel corporation in a variety of capacities, Fishburn was a senior technical program manager in DuPont until he was downsized out of his job during a recent restructure.

While at Intel, he earned a division recognition award for creating two

new processes that saved the division an estimated two million in time and resources.

Unemployed since October 2016, he recently decided to go into business for himself as a consultant.

His business, Six Pennies Consulting, now consults on project management, human resources, team development issues, executive coaching and the performance management of employees. many people don't know that the Port of Olympia serves all of Thurston County. "I want to strengthen the idea that led the people of Thurston County to create a public port in the first place: exploring new, forward looking, pioneering ways of developing our economy for the good for the county's residents."

Train tracks sabotaged to stop fracking equipment

WIP note: The following is a portion of an article posted anonymously on the Puget Sound Anarchists' news website (pugetsoundanarchists.org). As of April 24, this incident has not been reported in the daily Olympia newspaper. WIP has put out feelers and reliable sources have verified the article's claim of action taken.

"Early in the morning of April 20, 2017 we poured concrete on the train tracks that lead out of the Port of Olympia to block any trains from using the tracks. We took precautions to notify BNSF (the train company) - we called them and we used wires to send a signal that the tracks were blocked. We did this not to avoid damaging a train; nothing would bring bigger grins to our faces, but to avoid the risk of injuring railway workers.

"This action was done to disrupt the movement of trains carrying proppants used in natural gas fracturing. These train tracks are part of a system of pipelines, fracking wells, mines, clearcuts, control centers, fiberoptics, dams, highways and factories that cover the planet and are physical manifestations of a process that is destroying the ecosystems, cultures, and inhabitants everywhere. Behind this network of infrastructure there are politicians, CEOs and bureaucrats who have private security, cops, prison guards, non-profit directors, PR con-

national interests and a problematic conception of the U.S. working class.

Apart from soaring campaign rhetoric and outright propaganda, there is no idealized national interest. Every expression of U.S. national interest is actually the expression of the more or less stable, more or less contradictory,

more or less politically coherent interests of different classes, economic sectors, geographies, demographic groups, etc., as projected onto domestic and international politics. The two political parties do their best to contain and manage these divergent interests and to present, each of them, a version of the "national interest" most effective at keeping their amalgamated electoral coalitions aligned. In

other words, the content of what's understood by the term "national interest" is not abstract, unitary and ideal but rather highly politicized and reflective of the relative strength of contending political actors. All interests are particularistic and fragmentary. There is no reason to countenance the view that any one of the constituent elements is more representative of a unitary national interest than any other. That is to be fought out in the arena of politics, and is determined not only by demographic weight, but by the capacity to craft a vision and political agenda capable of unifying and stabilizing a coalition that is sufficiently powerful to project its worldview and political priorities as the "national interest."

The larger story of the working class.

As to the conception of the U.S. working class, the belated focus on the abandoned white worker traffics in a worn out motif that posits a white guy in a hard hat on a construction site or a factory floor as a stand-in for the working class in general, while declining to recognize that Black, Latino, Asian, female and LGBTQ workers have been battered by the same economic and social trends, that white male workers started at a higher baseline, and that

there's a racial and gender differential in the forms of and responses to the economic assault and battery.

Alarm bells have been rung, repeatedly, about rampant opioid abuse, rising suicide rates and detachment from the labor market in white working class communities. It is beyond question that political responses to these crises, by either party, have been inadequate, verging on criminally neg-

ing fortunes of the class as a whole; (2) refusing to make concessions to racism, xenophobia, Christian supremacy, misogyny or heterosexism while addressing those cerns; being clear that the displacement economic anxiety

being clear ligent, and that these communities that the post-war deal of expanding economic fortunes for a wide swath of white workers is completely off the table; what is on the table is the search for new forms of multi-racial, multi-ethnic, multi-gendered worker organizing that applies itself to the riddle of extracting significant concessions from 21st century capital; (5) understanding that winning the white working class away from thoroughly reactionary politics, is not principally an issue of crafting the best messages to produce results in the next election cycle, but a long-term, no-short-cuts proposition to which a battalion of people and organizations will need to devote their lives. We've only just begun.

Fortunately there are organizations doing the hard on-the-ground work in counties and states that are overwhelmingly white and/or red. They know the importance of place and how history and culture shape their neighbors' thinking. They know how many conversations it takes to get a first-time or infrequent voter to the polls. They know that race and gender bigotry, while tough to eradicate, are not immutable. They have mastered the art of building complex coalitions in which no constituency feels abandoned and all can move forward together. We all need to learn from these organizations and make sure their lessons are widely shared, their efforts resourced and replicated, rather than throwing buckets of money to Democratic Party consultants and operatives whose actions have much to do with the crisis we're in today.

The liberal imagination has become perversely fixated on the alleged excesses of "identity politics," forgetting that social movements of the marginalized are the spark and spur of democracy. The abolitionist and Civil Rights movements extended democratic rights to the formerly enslaved and perpetually reviled, removing a deep moral stain from the nation. The women's movement unleashed the talent of half the Country's population. While the smallminded argue about bathrooms and pronouns, transgender activists, at great risk to themselves, have gifted us with a more capacious understanding of the evolving spectrum of gender identity and expression. None of these movements is "done." Each has advanced not just the interests of a singular identity group, but also the ambit of freedom for all. Most assuredly, the generation that stepped forward in the wake of Trayvon Martin and Mike Brown will not stand down just because some liberals are having a panic attack.

> deserve the compassion, social and medical services, and jobs programs that could begin to turn these trends around. And yet.... I remember the 1980s, the cruel terminology-"crack babies" and "crack whores"-that accompanied that epidemic, and the unyielding resistance to naming the extended episode of drug dependency and addiction that tore through families and poor communities as a problem of the class. No, it was the "culture of poverty" and failure of character. Meaning poor Black people were simply inclined to do dope. So too the current wave of Chicago shootings is not read as revelatory of bottomless layers of desperation on the part of young working class men who are stripped, practically from birth, of access to lives that nurture their human potential, is not seen as a problem of class formation in the U.S., but is rather interpreted as inexplicable Black pathology and wielded politically to reinforce both class and race division. Obamacare repeal raises fears in local transgender communities

As the Republican-dominated federal government bickers about how to repeal and replace the Affordable Care Act (ACA), concerns about losing both healthcare and protection from discrimination are rising in the transgender community.

When asked if anybody was afraid of losing coverage if Obamacare is repealed, several people at the February support meeting of the Gender Alliance for the South Sound (GASS) said, "Who isn't?" GASS is a confidential, Tacoma-based organization that supports local transgender people. The group offers a space to discuss the process of transitioning, to offer solidarity, and to feel accepted and validated. At the mention of health care coverage, several people explained that Obamacare is crucial to their ability to access the

Until July of 2016, when Section 1557 of the ACA came into effect, trans people had little protection from discrimination. This provision specifies that, "individuals must be treated consistent with their gender identity, including in access to facilities," making healthcare more attainable for many trans people.

Without this anti-discrimination policy, many trans people struggled to get insurance companies to cover their medical needs. In a small, local survey conducted by this reporter, participants described instances of genderbased discrimination by healthcare providers. One trans woman said that until the non-discrimination clarification, Apple Health denied coverage of her hormone replacement therapy (HRT), which is a part of medical gender transition. Another respondent wrote, "Most healthcare providers do not know much about transgender people, and many would prefer to find other patients than to learn. Of course, the lack of hard information makes it difficult. There needs to be more research and more material for MD's

[sic] to learn from."

These experiences echo the national data. According to the National Trans-

port on Health and Health Care, survey participants reported, "very high levels of postponing medical care when sick or injured due to discrimination (28%) or inability to afford it (48%)," and, "50% [...] reported having to teach their medical providers about transgender care."

Transition-related medicine is an important part of treating the dysphoria many (though not all) transgender people experience. According to the American Psychiatric Association, gender dysphoria, 'involves a conflict between a person's physical or as-

signed gender and the gender with which [the person] identifies." Gender-confirming medical treatment can reduce or eliminate gender dysphoria which can be a major barrier to living a full, happy, and healthy life. However, despite the importance of medical transition for many trans people, it is not a part of most medical school education programs, and many insurance companies prefer to see hormone replacement therapy and gender-confirming surgeries as non-essential.

Some practitioners, however, are working to support trans patients. "I would often see [trans patients] pro bono," said Julie Dybbro, an ARNP, hormone expert, and owner of Complete Women's Health Care in Olympia. "Oftentimes they were homeless, they didn't have any money. I'd give them samples, I'd do whatever I could, but when insurance started paying, all the sudden it was a viable part of my

In addition to the fear of losing both healthcare and protection from dis-

Nancy Armstrong, an ARNP in Olympia, expressed concern that religious freedom legislation would allow providers to deny patients care. "There are people who are really uncomfortable with [treating trans and gender nonconforming people]," said Armstrong. "I've been a nurse for thirty-six years and I was never taught that way. I took care of people no matter what.'

Trans individuals are more likely to experience gender-based discrimination in medical settings than cis (non-trans) people. In the same local survey, 56% of trans participants reported facing discrimination based on gender identity compared to 20% of cis people. All of that 20% were women who reported experiencing sexism.

However, some clinics, like the Rainbow Health Center in Olympia, actively seek to be welcoming. This is evidenced by the rainbow flag flying on the front of the building. It's impossible to miss from 4th Avenue.

Dr. Matt Goldenberg, a clinical psychologist who works in the Rainbow Health Center, makes it a priority to accept Medicare and Medicaid. "As

> a provider," Goldenberg said, "that's a commitment I make to make sure that I'm seeing people who may not be eligible for service anywhere else." Many providers don't take Medicaid and Medicare which have much lower reimbursement rates than other insurance. "From a business perspective, there's not much incentive to take half a payment for the same work," Goldenberg explained, "but from a social justice perspective, it is really important to do it."

Dr. Goldenberg also co-owns ReLearn LLC whose mission is, "to build safer and more inclusive environments by training and educating healthcare professionals, employers, parents, and educators about gender identity and gender

Many providers are determined to continue serving trans patients. "If Obamacare gets repealed," said Dybbro, "I'm going to have to get very creative again. We've been there before, and we'll figure it out."

Recycled asphalt is still a threat to the Nisqually Valley

The Lakeside Industries plant was built in the Nisqually Valley area of Thurston county. This Nisqually Valley area has zoning regulations prohibiting RAP (Recycled Asphalt) in asphalt manufacturing. Now the Thurston County Commissioners, this GOP Tea Party group, is going to change all of this, and allow Recycled Asphalt into the Nisqually Valley.

Recycled asphalt is more polluting than regular asphalt. The recycled asphalt has more facets than regular asphalt. These facets of the rock are what dissolve in exposure to water.

Environmental and public hazards

The bitumen binder used in asphalt paving applications contains a relatively high concentration of a family of organic compounds that has the potential to pose human health and environmental concerns in certain circumstances, especially when asphalt material is ground into very small particles that easily blow off of or wash

These compounds, known as polycyclic aromatic hydrocarbons (PAHs) are present in RAP at higher levels than the criteria established by the NJDEP's Site Remediation Program guidance for general use in a loose fashion on land. RAP used alone without a paved top surface has the potential to significantly migrate from the roadway through the actions of water, wind, and physical displacement and possibly contaminate surrounding soils and/or surface water sediments. Traffic traveling on the unpaved RAP could generate dust containing the compounds referenced above and the dust would be a major migration route of the RAP to the surrounding environment.

Lakeside production manager Bill Dempsey, who wants this polluting Recycled Asphalt, said the company knew about the restrictions when they built the plant off Durgin Road Southeast, in 2008. This industry is inside the Holroyd gravel mine, which supplies rock for Lakeside's asphalt.

"We were opposed to them doing the asphalt in the first place," said Jan Pigman, owner of the 10-acre Pigman's Organic Produce Patch, which is about a half a mile away from the asphalt plant. She sells her farm's corn, strawberries and other produce at the Olympia Farmers Market, and she is concerned that recycled products run through the plant could carry toxic materials and cause pollution. If that happened, her farm could be at risk of losing its organic certification,

"We don't want RAP because we don't know what kind of pollutants are apt to be in that," Pigman said, " we do not want the capability to produce 300 tons of asphalt per hour."

Currently the Lakeside Industries company has tried to get Thurston county's regulations, which are part of the Nisqually Sub-Area Planning Area, amended to allow recycled asphalt. This is happening right now, April 2017. Lifting Thurston County's RAP prohibition would open the door for the company to recycle shingles, which are 99 percent oil, and could be crushed and added into the asphalt mix. That is the bottom line, we are talking about an industry using oil based products, in the Nisqually Valley, this valley that floods every few years here in Thurston County.

"The Nisqually Valley is zoned for agricultural use," the farmers say. There are many farms in this fertile area, as was mentioned above.

Lakeside's asphalt plant was approved in April 2001 by a hearing examiner, but foes appealed the decision to the Thurston County Commission, saying it conflicted with the county plan adopted in 1992 to protect the

CDGB grants on a rotating basis via the County. In 2017, the City of Lacey will receive \$867,000 in CDGB grants. These funds could be used for housing, capital improvement, community facilities and public services that benefit low and moderate income residents of the city.

HOME Investment Partnership Program

Elimination of HOME Investment Partnership Program, a program of the Department of Housing and Urban Development. This program and two others (Choice Neighbors & Homeownership Opportunity) will mean a "targeted reduction" of \$1.1 billion dollars. HOME funds can only be used for affordable housing programs.

The HOME consortium is an advisory body to the Thurston County Board of Commissioners. It distributes federal HUD HOME funds, federal HUD Emergency Solutions Grants (ESG), as well as State funds, to Olympia, Lacey, Tumwater, Yelm, Tenino, Bucoda, Rainier and the County. In the year September 2015 to August 2016, this Consortium expended \$3.3 million for affordable housing and homeless activities including the shelter system, rental assistance, and transitional

Some of the recipients of this \$3.3 million in mixed federal and state funds were: Catholic Community Services (\$65,3910), Community Action Council (\$850,998), Community Youth Services (\$167,350), Family Support Center (\$325,293), Interfaith Works (\$172,588) Panza (Quixote Village), (\$20,250) SafePlace (\$40,500), Salvation Army (\$48,700) and Sidewalk

(\$192,711).

Federal HOME funds accounted for \$528,594 of this total. This is the program explicitly eliminated by the America First budget. Some of these funds went to Habitat for Humanity (\$160,000), Homes First (\$115,735) and Housing Authority of Thurston County (\$274,293 with some ESG \$).

Institute of Museum and Library Services

Elimination of the Institute of Museum and Library Services. The Institute is the main source of federal support for libraries and museums within the US. It had a \$227 million dollar budget in 2015.

The Institute awarded a \$148,488 grant in fiscal year 2015 to the Hands On Children's Museum of Olympia to increase meaningful math and science experiences for young children, including those from at-risk and under-served families, their parents and caregivers and preschool and early elementary teachers. The Institute has also funded an extraordinary number of "Native American Library Services" including grants to the Nisqually Indian Tribe: \$7,000 (2016), \$7,000 (2015), \$40,492 (2015) and \$7,000 (2014).

foreign troops including the fighters for ISIS, most of whom are not Syrian, left Syria, I believe the Assad regime would collapse and the jihadist forces would be weakened. The Syrian people would have the opportunity to create their own future and type of society they wanted. This call for leaving Syria includes but is not limited to the United States. While the U.S. has played a horrible role in the Middle East, more than any other country, it is not the main cause of the plight of the Syrian people at this moment.

I support U.S. military aid and training of the YPG/PYD in Rojava in northern Syria. Although we should not romanticize and be uncritical of their society and rule, what is going on is positive and impressive in terms of women's major role in the struggle and governance there, the centrality of economic cooperatives, somewhat democratic decision-making and a level of sectarianism and repression far less than in most parts of Syria. Although the U.S. motives for military aid to the government of Rojava are not for humanitarian reasons much less to support an alternative to capitalism, United States. support helps them survive against ISIS. The People's Protection Units (YPD) have played a major role in defending Kurds and other Syrian people in this region against ISIS and with support from the United States have won several victories against ISIS. Very positive is solidarity and aid by grassroots groups around the world for the Kurdish people and their organizations in Rojava.

We, the people of the United States and our organizations, should also demand that the U.S. accept all refugees from Syria and from other places such as Somalia who want to come here and urge European countries to do the same. We should welcome the refugees and demand that they be treated with dignity and respect and have access to jobs, education and social services.

We should also demand although very, very difficult to achieve, the end of U.S. support, military aid and sales of military equipment to reactionary regimes in the Middle East such as Israel, Egypt, Saudi Arabia, Qatar, etc. The murderous military campaign, waged by Saudi Arabia, supported by the Unites States in Yemen, is also horrific, causing mass hunger and mass murder and we should organize and act against it as we oppose the current Syrian government and their international supporters' role in Syria.

People in Syria are hungry, wounded, sick and unemployed. We should support non-military, humanitarian aid that gets to the Syrian population. There is a case to be made for U.S.

military support to local communities and non-Jihadist armed groups trying to survive or resist the Syrian state apparatus as long as the Assad regime is so heavily supported by Russia and Iran. This is already happening, see

We should support the call for a real Syrian cease-fire with a simultaneous call for a major peace conference consisting of the Syrian government, all Syrian groups, armed and unarmed, including the existing Local Coordinating Committees (LCC) that were established in 2011 to oppose the Assad dictatorship, Syrian exile groups, and foreign governments involved in Syria. Although extremely difficult to bring about and even more difficult for an agreement to result, such a conference of all parties could result in less violence against the Syrian people, peace, and the possibility of a future rebuilding of Syria with the return of many Syrians in exile.

There should also be solidarity of all kinds for progressive and left groups inside Syria and of Syrian exile groups by grassroots global justice, peace and left groups around the world, including the United States. These Syrian groups continue to exist. Except perhaps in Rojava, there are not major groups in Syria like the NLF in Vietnam or the FMLN in El Salvador or URNG in Guatemala that much of the left in the United States and around the world supported in the past. It is much harder to envision a just outcome in Syria than there was in Indochina or Central America in the 1960's to 1980's. It is our responsibility to learn more about Syria, to see beyond the apologists for Assad and Putin but also to see beyond the one-dimensional analysis of most Democratic and Republican Party officials and the mainstream media in the United States who assert contrary to all evidence that the U.S. government and military and corporations are forces for good around the world who are motivated to further democracy and human rights. The right of the U.S. to attack or invade or intervene in other countries should be but usually is not questioned by the establishment. Moreover, the main casualties if examined or discussed at all are usually only the U.S. ones. Let us put the Syrian people at the center of our thoughts and analysis and actions in this horrific war.

Fifty years ago, Martin Luther King Jr. delivered his "Beyond Vietnam" speech, condemning the "giant triplets of racism, extreme materialism, and militarism." One year to the day after that speech, he was assassinated. Fifty years later, we still face the same demons. National Priorities Project has released its first analysis of the U.S. "militarized" budget, showing how use of force abroad and at home limits our

"When machines and computers, profit capacity to realize human potential. The United States is the single biggest military spender in the world. But there is an analog here at home: spending on policing, incarceration, immigration enforcement, and the war on drugs. In 2016, the militarized budget was \$741 billion, amounting to 64 percent of discretionary spending. ons and their effects. "We tried to wake people up to what Trident can do—the indiscriminate killing of mass numbers of people."

On the stand, Bernie Meyer said, "The experts are warning us. We have to give up business as usual." He said there must be trust among world leaders in order to solve the existential problems we face, particularly nuclear weapons and climate change. He also quoted former Secretary of Defense William Perry who recently said that it is up to the people to speak out and demand action on nuclear weapons.

During Blake Kremer's closing statement he said, "These defendants have knowledge that some courts and legal scholars believe they have a right and even an obligation to bring their message of peace and nonviolence to the base commander and the government and that the im-

portance of this message makes it necessary and legally justifiable for them to stand on base while attempting to deliver this message." Sadly, the court made it impossible for the defendants to use any defenses that have been recognized in other courts! Kremer's full closing statement can be found at www.gzcenter.org

When all was said and done, the judge ruled against the defendants based on the "facts" and found all three guilty of trespassing. Referring to the defendant's "unrepentant" attitudes, the government asked for one year of supervised probation and one hundred hours of community service. The judge agreed with the sentencing request, and, in addition to probation and community service, assessed the

> defendants a \$10 mandatory court assessment plus a \$25 processing fee.

> As much as the defendants attempted to bring light to the real crime-the

continuing threat of use of Trident against other nations-justice was not served in the courtroom on this day. Instead, the National Security State protected its narrow interests rather than upholding the Constitution of the United States along with the rights of all humanity to live free from the threat of nuclear annihilation.

The Trident submarine base at Bangor houses the largest concentration

> of deployed nuclear weapons in the US and is the home port for eight of the Navy's Trident nuclear fourteen powered submarines. More than 1,300 nuclear warheads are deployed on Trident D-5 missiles on SSBN submarines based at Bangor or are stored at Strategic Weapons Facility Pacific (SWFPAC) at the Bangor submarine base.

> One Trident SSBN submarine at Bangor is estimated to carry about 108 nuclear warheads. The W76 and W88 warheads at Bangor are equal, respectively, to 100 kilotons and 455 kilotons of TNT in destructive force. One submarine deployed at Bangor is equal to more than 1,400 Hiroshima-sized nuclear bombs. The nuclear warheads at SWFPAC and on

submarines based at Bangor have the combined explosive power equivalent to more than 14,000 Hiroshima bombs.

A March 2017 report from the Bulletin of the Atomic Scientists shows that the US has been upgrading the W76 warhead and has developed a "superfuze" that makes the refurbished warhead three times as lethal as before. This huge increase in kill capability makes it appear as if the United States is preparing for a decapitating nuclear

Before the trial, supporters held vigil in front of the Tacoma Union Station Courthouse carrying signs that read, "Abolish Nuclear Weapons," and handed out leaflets about the trial.

Prior to their trial, each of the Trident Three made a statement describing the reasons for their collective action against nuclear weapons.

Bernie Meyer: "We are at a juncture, a juncture that we created, that is of our own doing. We created nuclear weapons, nuclear power, a whole system of radiation dispersal. We created a way of life that spews carbon dioxide, methane, and more chemicals into the atmosphere which circulates into the oceans and onto the continents and heats them up beyond our accustomed tolerance. What do we do? What will you do?"

Gilberto Perez: "A moral consciousness is needed in realizing love and compassion for all. The revolution of the heart melts away the walls of hate and war. We must love each other or nuclear annihilation is inevitable. We

are not alone."

Larry Kerschner: "Twenty miles west of Seattle is the largest concentration of deployed nuclear weapons in the US. It is clear that the actual use of nuclear weapons would grossly violate the international laws of humanitarian armed conflict under any conceivable circumstances. How can the US threaten the use of nuclear weapons without violating international law? The Nuremberg Principles absolutely proscribe crimes against peace, crimes against humanity, and war crimes. How can the US Government lawfully establish a threat to commit such heinous offenses?"

May we all know where we stand, and stand there.

Exposing fear and anger so we can make progress

Expose politicians' exploitation of fear

Throughout the 2016 election campaign season and after his inauguration, Trump was provoking fear and anger. He provoked fear of various groups of vulnerable people and urged people to retaliate against them. He exploited people's fear of economic and social insecurity then directed people's antagonism at the wrong targets. After making people afraid and angry, the remedy he proposed was to elect him – the big, strong man – to protect us from Mexicans, Muslims, uppity blacks, feminists, gays, Iran, and so forth.

Trump's provocation and exploitation of fear is exactly what dictators do. Make people afraid of "the other" and assert that only he—the dictator—is strong enough to protect people from those dangers. Trump created and promoted his public image as a strong business leader, a tough negotiator, the strong man who will protect us from whatever frightens us. Other dictators have used this same approach to target Jews or Communists, and now Trump has used it against the targets that he chose. The dynamics are the same.

Notice that nothing that Trump has said or done would actually solve problems. It's all about provoking fear, anger and blame targeted at vulnerable people. It's all negative. The few remedies he has proposed are all baloney.

EXAMPLE #1: The Trumpcare/Ryancare alternative to Obama's ACA was incredibly cruel to people and was actually a scam offering massive tax breaks for the richest Americans.

EXAMPLE #2: Trump's proposed wall along our Mexican border is a phony remedy intended to hype fear and anger toward Mexicans - and to distract white Americans from reality. Actually, most of the people—who are in the U.S. without documentationarrived here legally and simply overstayed their tourist visas, student visas or work visas. They came from many different countries. Immigration from Mexico has declined sharply in recent years. So Trump's wall would not solve any real problems, but it served as a political gimmick for inciting fear and anger. Of course, such a big project would need to be built by big businesses, so that would enrich his cronies.

EXAMPLE #3: His radical trashing of governmental "regulations" actually is a radical elimination of protections for people and the environment. Big business has been polluting our environment, so government has passed laws and regulations to protect the environment and public health. Big banks and credit cards have been ripping off consumers, so government has passed laws and regulations to protect

ordinary people from financial and legal abuse. I remember the 1950s and 1960s when very serious coal mining accidents occurred frequently and killed many people, and we used to have more passenger airplane crashes (source?) and automobile accident deaths, so the government passed laws and regulations to improve safety in various ways. When right-wing politicians denounce "regulations," they are denouncing protections for people and our environment.

Throughout history other politicians of both parties have cynically provoked fears too. In 1960 Democrat John F. Kennedy-running against Republican Richard Nixon, who was finishing his second term as President Eisenhower's Vice President-claimed (contrary to the truth) that there was a "missile gap" in which the U.S. was lagging behind the Soviet Union, and Nixon should be blamed. In 1968 George Wallace and Richard Nixon ran presidential campaigns that exploited white fears of African Americans and older people's fears of young people who opposed war and social injustices.

Wisely, Franklin D. Roosevelt said in 1933—immediately after becoming President during the Great Depression – "The only thing we have to fear is fear itself." He took many bold actions to activate the federal government in solving various aspects of our nation's most serious economic crisis. His positive actions and his repeated statements against fear gave the nation confidence that we could indeed solve problems.

Trump and the right-wing Congress are doing the opposite. They utterly refuse to solve problems. They are disempowering federal agencies in order to prevent the government from solving problems. They threaten state and local governments that want to solve problems (e.g., related to the environment, immigrant rights, women's health, economic justice, reducing harm from drug use).

Our organizing efforts should explicitly expose how Trump and Congress are promoting fear, trying to disempower people, and cynically refusing to solve problems.

Fear tends to disempower people

This article's first two paragraphs point out that politicians promote fear for two reasons: (1) they focus people's negative emotions against a vulnerable target population; and (2) they position themselves as the strong man who is the only person who can save the public from the dangers posed by "the other." Indeed, during the campaign Trump kept saying that only he could save us from the dangers he was exploiting.

Decades ago Abraham Maslow devised a model that identified people's "Hierarchy of Needs." Self-actualiza-

tion and esteem were near the top, but people could pay attention to meeting those needs only after they had met their basic survival needs (food, housing, security, safety, etc.).

A civilized nation recognizes these basic survival needs as inherent human rights, so a civilized nation works to meet these needs for every person. Having achieved that, a civilized nation helps people meet the higher needs in various ways. Tyrants and abusive economic systems push people downward on Maslow's Hierarchy of Needs. Tyrants disempower and oppress people by—among other methods-threatening people's basic survival needs in order to extract labor from them under unjust conditions. Tyrants threaten those basic survival needs in order to unjustly force people to become loyal to the oppressive regime in order to seek basic survival and safety.

We see this happening now with the right wing slashing services for poor people, reducing workers' rights, concentrating economic power in big business's hands, "de-regulating" and stripping away the government's protections of people and our environment, etc.

All of these put the basic survival of ordinary people at serious risk. Insights from Maslow's Hierarchy of Needs suggest that these right-wing threats to people's survival push people downward on the hierarchy so people will have less self-esteem and be less able to "self-actualize;" people will have to scramble harder for mere survival, which saps their energy and self-respect so they will be less able to organize to protect their rights. This in turn makes people even more dependent on the right-wing oppressors.

When people are trampled upon in these ways, they can feel disempowered. We have an alternative.

Let's strategize to expose and dismiss fear, so we can make progress.

Many of the issues that politically progressive people work on—climate, racism, nuclear weapons, death penalty, etc. – have emotional complexities that we must address, in addition to educating the public about the facts.

For example, if somebody is so deep-

ly afraid of crime that they demand knee-jerk "tough-on-crime" laws, they will not be psychologically open to learning about how unjust the death penalty is. Their fear of crime is a psychological barrier to solving the problem and abolishing the death penalty. So besides presenting the facts, we must simultaneously devise strategies to reduce fear and other psychological barriers that prevent people from learning about the death penalty and pushing to abolish it. In fact, even the very topics of murder and death are unpleasant for most people to deal with, so we must figure out how to reduce those barriers too.

Likewise, we need to recognize the fears and other psychological barriers that make people avoid acknowledging problems of racism, nuclear weapons, the climate crisis, etc. We can make progress on these issues only if we devise smart strategies to deal with fears and other psychological barriers, in addition to devising ways to educate the public and politicians about the facts. No amount of facts can penetrate a person's psychological defenses, so we must strategize about how to deal with psychological factors before people will be able to hear and absorb our facts.

This psychological factor is a crucial "missing link" in progressive movements' organizing. Recognizing this may help us have compassion for people who are stuck in their psychological defenses compounded by a lack of factual knowledge. In order to move the grassroots toward organizing remedies for solving problems, we must start where people are now, understanding the psychological factors that can become traps, and compassionately help people get unstuck and move ahead.

Most organizing neglects this crucial first step.

Profound nonviolence and compassion are absolutely vital parts of strategies for helping our nation recognize the cruelty and oppression of Trumpism and right-wing politics. If we are strategically and psychologically savvy together, we can turn things around!

valley. This Thurston County Plan to protect the Nisqually valley used many different groups working on it, particularly the Nisqually Tribe that relies on the fish from the Nisqually River. The old Thurston County commissioners overturned the approval of the RAP Plant, from the hearings examiner. Lakeside Industries appealed their decision in Mason County Superior Court in June 2002.

A Mason County judge ruled against the county, saying the plan did not prohibit asphalt plants. The county and opponents appealed that ruling to state superior court which ruled that an asphalt plant could be built in the valley, but it would not be allowed to process RAP. So that is the law right now. The GOP Tea Party commissioners will probably get their way, and allow RAP in the Nisqually Valley. Please get involved.
